10. **Item 9(b)**

The Board of Directors of Megaworld Corporation ("Megaworld" or the "Company") has approved the Company's debt securities program of up to PHP30.0 billion with an initial issuance of fixed-rate bonds of up to PHP8.0 billion with an oversubscription option of up to PHP4.0 billion (the "Bonds"). Megaworld has appointed BDO Capital & Investment Corporation as issue manager, lead underwriter and bookrunner for the Bonds. The proceeds from the Bonds will be used to fund the capital expenditures of the Company.

The determination of pricing, terms and conditions, and other features of the Bonds is delegated to Megaworld management. A subsequent disclosure to the Securities and Exchange Commission and the Philippine Dealing and Exchange Corporation shall be done as soon as the Board of Directors approves the final size, pricing and terms and conditions of the Bonds.
