Andrew L. Tan, Katherine L. Tan, Kingson U. Sian, Enrique Santos L. Sy, Miguel B. Varela, Gerardo C. Garcia and Roberto S. Guevara were elected to the Board of Directors. Miguel B. Varela, Gerardo C. Garcia and Roberto S. Guevara will serve as independent directors.

Stockholders owning or representing at least two-thirds of the outstanding capital stock of the Company approved a Php10 billion increase in its authorized capital stock, resulting in an authorized capital stock of Php40.2 billion divided into 40,140,000,000 common shares each with a par value of One Peso (Php1.00) and 6,000,000,000 voting, cumulative, non-participating, non-convertible and non-redeemable preferred shares each with a par value of One Centavo (Php0.01).

Alliance Global Group, Inc. subscribed to 25% of the Php10 billion increase equivalent to 2.5 billion common shares at the subscription price of Php4.29 per share for an aggregate price of Php10.725 billion.

The stockholders approved the engagement of Punongbayan & Araullo as external auditors of the Company for the year 2013.
