- The Corporation is required to file with the Securities and Exchange Commission ("SEC") its attached General Information Sheet for the year 2013 ("GIS") within 30 days from its annual stockholders meeting last 18 July 2013.

- The Corporation undertakes to write to each and every concerned stockholder in its top twenty stockholders whose TIN is not indicated to request for their TIN and to submit an amended GIS already indicating the TIN of its top twenty stockholders after receipt of the TIN from its stockholders but not later than 15 February 2014.
