**AFFIDAVIT OF UNDERTAKING**

I, ROLANDO D. SIATELA, of legal age, Filipino and with office address at 16/F The World Centre, 330 Sen. Gil Puyat, Makati City, Metro Manila, after having been sworn in accordance with law, hereby states that:

1) I am the Assistant Corporate Secretary of MEGAWORLD CORPORATION (the "Corporation"), a corporation organized and existing under Philippine laws with office address at 28/F The World Centre 330 Sen. Gil Puyat Avenue, Makati City, Metro Manila.

2) The Corporation is required to file with the Securities and Exchange Commission ("SEC") its attached General Information Sheet for the year 2013 ("GIS") within 30 days from its annual stockholders meeting last 18 July 2013.

3) Last 16 August 2013, the Corporation attempted to file the GIS but the SEC refused to receive the same on the ground that the tax identification numbers ("TIN") of some stockholders included in the list of top twenty stockholders are not indicated therein.

4) The Corporation is listed with the Philippine Stock Exchange, Inc. ("PSE") and its shares are held by about 2,698 stockholders worldwide.


5) Accordingly, the Corporation has no access to most of the stockholders included in its top twenty stockholders and is constrained to rely on the records of its stock transfer agent.

6) The Corporation has diligently searched the records of its stock transfer agent but has failed to complete the required TIN of its top twenty stockholders.

7) The Corporation undertakes to write to each and every concerned stockholder in its top twenty stockholders whose TIN is not indicated to request for their TIN and to submit an amended GIS already indicating the TIN of its top twenty stockholders after receipt of the TIN from its stockholders but not later than 15 February 2014.





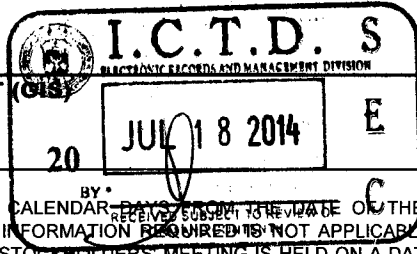
