1. CORPORATE INFORMATION

Megaworld Corporation (the Parent Company) was incorporated in the Philippines on August 24, 1989, primarily to engage in the development of large scale, mixed-use planned communities or townships that integrate residential, commercial, leisure and entertainment components. The Parent Company is presently engaged in property-related activities such as project design, construction and property management. The Parent Company's real estate portfolio includes residential condominium units, subdivision lots and townhouses, condominium-hotel projects as well as office projects and retail spaces.

Alliance Global Group, Inc. (AGI or the Ultimate Parent Company) is the ultimate parent company of Megaworld Corporation and its subsidiaries (the Group). AGI is a holding company and is presently engaged in food and beverage, real estate development, quick-service restaurant, tourism-entertainment and gaming businesses.

The Parent Company and AGI's common shares are publicly-listed at the Philippine Stock Exchange (PSE).

The Parent Company's registered office address, which is also its principal place of business, is located at 30th Floor, Alliance Global Tower, 36th Street cor. 11th Avenue, Uptown Bonifacio, Taguig City. AGI's registered office address, which is also its principal place of business, is located at the 7th Floor, 1880 Eastwood Avenue, Eastwood City CyberPark, 188 E. - (b) As at June 30, 2023, the Parent Company owns 76.55% of MCPI consisting of 51% direct ownership, 18.97% indirect ownership through EELHI and 6.58% indirect ownership through MREI.
- (c) As at June 30, 2023, the Parent Company's ownership in GPMAI is at 52.14%, which consists of 38.72% and 13.42% indirect ownership from EELHI and MREI, respectively.

In May 2023, the company disposed certain number of shares which decreases the ownership to 65.62%.
- (g) KHMI was incorporated in 2020 and engaged in hotel operations.
- (b) In 2021, the Company acquired additional common shares of STLI from previous stockholders representing 1.44% direct ownership. As at December 31, 2022, the effective ownership of the Company over STLI is 98.41%, consisting of 18.84% direct ownership and 79.47% indirect ownership through SPI.
- (i) In 2021, the SEC approved the application of MDC for the decrease of its authorized capital stock. As a result, MDC paid a total of P355.0 million to its current stockholders for the return of capital. The Parent Company's ownership interest over MDC remains at 60%.
- (j) PCMI is a subsidiary through EELHI. In 2021, certain number of shares owned by the Parent Company were transferred to the Company, increasing the effective ownership of the Company to 58.53%, which consists of 25.83% direct ownership and 32.69% indirect ownership from EELHI.

All subsidiaries and associates were incorporated and have their principal place of business in the Philippines except for the following:

- MCII incorporated and has principal place of business in the Cayman Islands

- SPML incorporated and has principal place of business in Hongkong
- WPML incorporated and has principal place of business in Macau

The Company and its subsidiaries, except for entities which have not yet started commercial operations as at June 30, 2023, are presently engaged in the real estate business, hotel, condominium-hotel operations, construction, restaurant operations, business process outsourcing, educational facilities provider, property management operations, fund management operations, marketing services and e-commerce.

EELHI, GERI, MREIT and SUN are publicly-listed companies in the Philippines.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies that have been used in the preparation of these interim condensed consolidated financial statements are consistent with those applied in the audited consolidated financial statements as of and for the year ended December 31, 2022, except for the application of amendments to standards that became effective on January 1, 2023 (see note 2.2)

2.1 Basis of Preparation of Interim Condensed Consolidated Financial Statements

(a) Statement of Compliance with Philippine Financial Reporting Standards

These interim condensed consolidated financial statements for the six months ended June 30, 2023 and 2022 have been prepared in accordance with Philippine Accounting Standard (PAS) 34, Interim Financial Reporting. They do not include all the information and disclosures required in the annual consolidated financial statements and should be read in conjunction with the audited consolidated financial statements of the Group as at and for the year ended December 31, 2022.

The preparation of interim condensed consolidated financial statements in accordance with Philippine Financial Reporting Standards (PFRS) requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. Although these estimates are based on management's best knowledge of current events and actions, actual results may ultimately differ from those estimates.

These interim condensed consolidated financial statements are presented in Philippine peso, the functional and presentation currency of the Group, and all values represent absolute amounts except when otherwise indicated.

(b) Functional and Presentation Currency

These consolidated financial statements are presented in Philippine Peso, the Group's presentation and functional currency, and all values represent absolute amounts except when otherwise indicated.

Items included in the interim consolidated financial statements of the Group are measured using the Group's functional currency. Functional currency is the currency of the primary economic environment in which the Group operates.

2.2 Adoption of New and Amended PFRS

Discussed below are the relevant information about these pronouncements.

- (i) PAS 16 (Amendments), *Property, Plant and Equipment Proceeds Before Intended Use.* The amendments prohibit deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognizes the proceeds from selling such items, and the cost of producing those items, in profit or loss. The application of these amendments had no significant impact on the Group's interim consolidated financial statements as there were no sales of such items produced by property, plant and equipment made before being available for use on or after the beginning of the earliest period presented.
- (ii) PAS 37 (Amendments), Provisions, Contingent Liabilities and Contingent Assets Onerous Contracts – Cost of Fulfilling a Contract. The amendments specify that when assessing whether a contract is onerous or loss-making, an entity needs to include costs that relate directly to a contract to provide goods or services. Costs that relate directly to a contract include both incremental costs of fulfilling that contract (e.g., direct labor and materials) or an allocation of other costs that relate directly to fulfilling contracts (e.g., the allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract). The amendments resulted in a revision in the Group's policy to include both incremental costs and an allocation of other costs when determining whether a contract was onerous.

The amendments apply prospectively to contracts existing at the date when the amendments are first applied. Management assessed that there is no significant impact on the Group's interim consolidated financial statements as a result of the change since none of the existing contracts as of January 1, 2022 would be identified as onerous after applying the amendments.

(iii) Annual Improvements to PFRS 2018-2020 Cycle. Among the improvements, the following amendments which do not have significant impact and which are effective from January 1, 2022, are relevant to the Group's interim consolidated financial statements:

- PFRS 9 (Amendments), *Financial Instruments Fees in the '10 per cent' Test for Derecognition of Liabilities.* The amendments clarify the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf.
- Illustrative Examples Accompanying PFRS 16, *Leases Lease Incentives*. The amendments remove potential for confusion regarding lease incentives by deleting from Illustrative Example 13 the reimbursement relating to leasehold improvements as it had not been explained clearly enough as to whether the reimbursement would meet the definition of a lease incentive in accordance with PFRS 16.

There are pronouncements effective for annual periods subsequent to 2021, which are adopted by the FRSC. Management will adopt the following relevant pronouncements in accordance with their transitional provisions; and, unless otherwise stated, none of these are expected to have significant impact on the Group's interim consolidated financial statements:

- (i) PAS 1 (Amendments), Presentation of Financial Statements Classification of Liabilities as Current or Non-current (effective from January 1, 2023)
- (ii) PAS 1 and PFRS Practice Statement 2 (Amendments), *Presentation of Financial Statements Disclosure of Accounting Policies* (effective from January 1, 2023)
- (iii) PAS 8 (Amendments), Accounting Estimates Definition of Accounting Estimates (effective from January 1, 2023)
- (iv) PAS 12 (Amendments), Income Taxes Deferred Tax Related to Assets and Liabilities Arising from a Single Transaction (effective from January 1, 2023)

# 3. SIGNIFICANT ACCOUNTING ESTIMATES AND JUDGMENTS

In preparing the interim condensed consolidated financial statements, management undertakes a number of judgments, estimates and assumptions about recognition and measurement of assets, liabilities, income and expenses. The actual results may differ from the judgments, estimates and assumptions made by management, and will seldom equal the estimated results. The judgments, estimates and assumptions applied in the interim condensed consolidated financial statements, including the key sources of estimation uncertainty, were the same as those applied in the Group's last annual financial statements as at and for the year ended December 31, 2022. The Group performed its annual impairment test of goodwill and other intangible assets with indefinite useful life at year end and when circumstances indicate the carrying value may be impaired. The Group's impairment test for goodwill arising from business combination and other intangible assets is based on value-in-use calculations. The Group considers the relationship between the market capitalization of the subsidiaries and its net book value, among other factors, when reviewing for indicators of impairment. The Group's management assessed that for the six months ended June 30, 2023 and as at December 31, 2022, goodwill arising from business combination and other intangible assets with indefinite useful life are not impaired.

# 4. SEGMENT INFORMATION

# 4.1 Business Segments

The Group's operating businesses are organized and managed separately according to the nature of products and services provided, with each segment representing a strategic business unit that offers different products and serves different markets. The Group is engaged in the development of residential and office units including urban centers integrating office, residential and commercial components. The Real Estate segment pertains to the development and sale of residential and office developments. The Rental segment includes leasing of office and commercial spaces. The Hotel Operations segment relates to the management of hotel business operations. The Group generally accounts for intersegment sales and transfers as if the sales or transfers were to third parties at current market price.

# 4.2 Segment Assets and Liabilities

Segment assets are allocated based on their physical location and use or direct association with a specific segment and they include all operating assets used by a segment and consist principally of operating cash and cash equivalents, receivables, real estate inventories, property and equipment, and investment properties, net of allowances and provisions. Similar to segment assets, segment liabilities are also allocated based on their use or direct association with a specific segment. Segment liabilities include all operating liabilities and consist principally of accounts, wages, taxes currently payable and accrued liabilities. Segment assets and segment liabilities do not include deferred taxes.

# 4.3 Intersegment Transactions

Segment revenues, expenses and performance include sales and purchases between business segments. Such sales and purchases are eliminated in consolidation.

# 4.4 Presentation of Segment Information

In the year end 2022, the Group modified the presentation and measure of the performance of its operating segments such that only income and costs directly attributable to the segments are included. Following this change, the comparable segment information in the quarterly prior periods presented were restated to conform with the current period presentation.

# 4.5 Analysis of Segment Information

The tables presented in the succeeding page present revenue and profit information regarding industry segments for the six months ended June 30, 2023 and 2022 and certain asset and liability information regarding segments as at June 30, 2023 and 2022.

# 6. COMMITMENTS AND CONTINGENCIES

There are commitments, guarantees and contingent liabilities that arise in the normal course of operations of the Group which are not reflected in the accompanying interim condensed consolidated financial statements. The management of the Group is of the opinion, that losses, if any, from these items will not have any material effect on its consolidated financial statements.

In addition, there are no material off-balance sheet transactions, arrangements, obligations and other relationships of the Group with unconsolidated entities or other persons created during the reporting period.

# 7. SEASONAL FLUCTUATIONS

There were no seasonal aspects that had a material effect on the financial condition or results of operations of the Group.

# 8. RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group has various financial instruments such as cash and cash equivalents, financial assets at fair value through other comprehensive income (FVOCI), interest-bearing loans and borrowings, bonds payable, trade receivables and payables which arise directly from the Group's business operations. The financial liabilities were issued to raise funds for the Group's capital expenditures.

Exposure to currency, interest rate, credit, liquidity and equity risk arises in the ordinary course of the Group's business activities. The main objective of the Group's risk management is to identify, monitor, and minimize those risks and to provide cost with a degree of certainty.

The Group does not actively engage in the trading of financial assets for speculative purposes.

# 8.1 Foreign Currency Sensitivity

Most of the Group's transactions are carried out in Philippine peso, its functional currency. Exposures to currency exchange rates arise mainly from the Group's U.S. dollar-denominated cash and cash equivalents, loans and bonds payable which have been used to fund new projects and for general corporate purposes.

Exposures to foreign exchange rates vary during the period depending on the volume of overseas transactions and mainly affect consolidated profit or loss of the Group. There are no material exposures on foreign exchange rate that affect the Group's consolidated other comprehensive income (loss).

# 8.2 Interest Rate Sensitivity

The Group's interest risk management policy is to minimize interest rate and cash flow risk exposures to changes in interest rates. The Group maintains a debt portfolio unit of both fixed and floating interest rates. Most long-term borrowings are subject to fixed interest rate while other financial assets are subject to variable interest rates.

The Group manages its interest risk by leveraging the fixed interest rate debt obligations over the floating interest rate debt obligations in its debt portfolio.

# 8.3 Credit Risk

The Group's credit risk is attributable to trade receivables, rental receivables and other financial assets. The Group maintains defined credit policies and continuously monitors defaults of customers and other counterparties, identified either individually or by group, and incorporates this information into its credit risk controls. Where available at a reasonable cost, external credit ratings and/or reports on customers and other counterparties are obtained and used. The Group's policy is to deal only with creditworthy counterparties. In addition, for a significant proportion of sales, advance payments are received to mitigate credit risk.

# 8.4 Liquidity Risk

The Group manages its liquidity needs by carefully monitoring scheduled debt servicing payments for long-term financial liabilities as well as cash outflows due in a day-to-day business. Liquidity needs are monitored in various time bands, on a day-to-day and week-to-week, as well as on the basis of a rolling 30-day projection. Long-term needs for a nine-month and a one-year period are identified monthly.

The Group maintains cash to meet its liquidity requirements for up to 60-day period. Excess cash are invested in time deposits or short-term marketable securities. Funding for long-term liquidity needs is additionally secured by an adequate amount of committed credit facilities and the ability to sell long-term financial assets.

The Group's market price risk arises from its financial assets at FVOCI carried at fair value. It manages its risk arising from changes in market price by monitoring the changes in the market price of the investments.

The investments in listed equity securities are considered long-term strategic investments. In accordance with the Group's policies, no specific hedging activities are undertaken in relation to these investments. The investments are continuously monitored and voting rights arising from these equity instruments are utilized in the Group's favor.

# 9. CATEGORIES AND FAIR VALUES OF FINANCIAL ASSETS AND LIABILITIES

# 9.2 Fair Value Hierarchy

In accordance with PFRS 13, *Fair Value Measurement*, the fair value of financial assets and liabilities and non-financial assets which are measured at fair value on a recurring or non-recurring basis and those assets and liabilities not measured at fair value but for which fair value is disclosed in accordance with other releveant PFRS, are categorized into f levels based on the significance of inputs used to measure the fair value. The fair value hierarchy has the following levels:

- a) Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities that an entity can access at the measurement date;
- b) Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices); and,
- c) Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).

The level within which the asset or liability is classified is determined based on the lowest level of significant input to the fair value measurement.

For purposes of determining the market value at Level 1, a market is regarded as active if quoted prices are readily and regularly available from an exchange, dealer, broker, industry group, pricing service, or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.

For investments which do not have quoted market price, the fair value is determined by using generally acceptable pricing models and valuation techniques or by reference to the current market of another instrument which is substantially the same after taking into account the related credit risk of counterparties, or is calculated based on the expected cash flows of the underlying net asset based of the instrument.

When the Parent company uses valuation technique, it maximizes the use of observable market data where it is available and relies as little as possible on entity specific estimates. If all significant inputs required to determine the fair value of an instrument are observable, the instrument is included in Level 2. Otherwise, it is included in Level 3.

# **10. OTHER MATTERS**

# 10.1 Block Sale Transaction

On July 20, 2023, the Company launched an overnight placement of 279,400,000 common shares of MREIT equivalent to Php3.6 billion, under a block sale transaction. The block sale application was filed with the Philippine Stock Exchange on July 21, 2023.

# 10.2 Continuing Impact of COVID-19

The COVID-19 pandemic has had a lasting impact in the Philippines since it first emerged in March 2020. In July 2023, the government issued a proclamation lifting the State of Public Health Emergency throughout the Philippines.

The country's economic condition has shown a steady improvement in the second quarter of 2023. This can be attributed to the resumption of local and international travel, as well as the easing of health restrictions that were put in place due to the pandemic. The latest economic reports indicate that demand and supply have been steadily recovering to prepandemic levels. The Group has reported that its operations are almost back to prepandemic levels, resulting in a lessened impact from the COVID-19 pandemic.

In an effort to enhance operations, management has announced plans to take further actions and make ongoing improvements as required. Management is optimistic about the Group's future financial performance, citing recent improvements as evidence. They anticipate that the Group will maintain positive results of operations and have enough liquidity to meet upcoming obligations as they approach maturity. Management of the Group is expressing confidence in its ability to maintain its growth momentum despite concerns about the impact of the pandemic.

# **Results of Operations**

# (Based on Financial Statements adopted in accordance with the Philippine Financial Reporting Standards)

# Review of June 30, 2023 versus June 30, 2022

Megaworld, the country's largest developer of integrated urban townships, posted a net income of Php 8.84 billion in the second quarter of 2023, up by 31.23% from Php 6.73 billion in the same period last year, boosted by double-digit revenue growth across all of its business segments. Net income attributable to the parent company stood at Php 7.88 billion.

The Group's consolidated revenues grew by 16.72% to Php 32.04 billion in the second quarter of 2023 from Php 27.45 billion in the same period last year.

**Development.** Among product portfolios, the bulk of total consolidated revenues came from the sale of condominium units and commercial lots, comprising 59.51% of total revenues. Real estate sales grew by 12.22% year-on-year to Php 19.07 billion from the second quarter of previous year's Php 16.99 billion as construction activities picked up during the year. The Group's registered sales mostly came from the following projects: Bayshore Residential Resort 2 Phase 2, Arden Botanical Village, Park Mckinley West, Gentry Manor, Grand Westside Hotel, Sunny Coast Residential Resort, Uptown Parksuites Towers 1 & 2, Vion Tower, Uptown Ritz Residence, The Albany-Yorkshire & Kingsley, Park Mckinley West-Tower C, Uptown Arts Residences, The Florence, Manhattan Plaza Tower 2, Eastwood Global Plaza Luxury Residence, Golf Hill Gardens, Belmont Hotel Iloilo, Saint Dominique, 18 Avenue De Triomphe, Savoy Hotel Mactan Newtown

*Leasing.* The Group's rental businesses, consisting of office and lifestyle mall leasing, yielded an increase of 17.18%, reaching Php 8.80 billion in the second quarter of 2023 from the previous year's Php 7.51 billion, thereby contributing 27.46% of the total consolidated revenues.

*Hotel Operations.* The Group's revenues attributable to hotel operations posted a milestone growth of 58.15%, soared to Php 1.71 billion in the second quarter of 2023 compared to Php 1.08 billion from the same period last year.

Total costs and expenses amounted to Php 23.21 billion, an increase of 12% from Php20.72 billion in the same period last year. Interest and other charges – net decreased by 24.36%, amounting to Php 2.59 billion this year from Php 3.43 billion in second quarter of 2022. Tax expense in 2023 amounting to Php 2.13 billion resulted in an increase of 40.86% from 2022 reported amount of Php 1.51 billion.

There were no seasonal aspects that had a material effect on the financial condition or financial performance of the Group. Neither were there any trends, events or uncertainties that have had or that are reasonably expected to have a material impact on net sales or revenues or

income from continuing operations. The Group is not aware of events that will cause material change in the relationship between costs and revenues.

There are no significant elements of income or loss that did not arise from the Group's continuing operations.

# **Financial Condition**

The Group maintains a prudent financial policy as it engages in a more competitive and challenging environment. The Group's Statements of Financial Position reflects stable financial growth. Total resources as at June 30, 2023 amounted to Php 422.80 billion, posting an increase of 3.32% compared to Php 409.21 billion as at December 31, 2022.

The Group shows steady liquid position as at June 30, 2023 as reflected in its current assets at Php 233.71 billion as against its current obligations at Php 74.65 billion. Current assets posted an increase of 4.19% from December 31, 2022 balance of Php 224.32 billion. Current obligations reflected a decrease of 0.81% from December 31, 2022 balance of Php 75.25 billion.

Cash and cash equivalents decreased by 10.45% from Php 27.75 billion in 2022 to Php 24.85 billion as at June 30, 2023. Current and non-current trade and other receivables – net increased by 3.68%, amounting to Php 59.04 billion as at June 30, 2023 compared to Php 56.94 billion as at December 31, 2022. Contract assets increased by 16.55%, amounting to Php 22.87 billion as at June 30, 2023 compared to Php 19.62 billion as at December 31, 2022. Inventories increased by 5.30% from Php 123.45 billion in 2022 to Php 130 billion as at June 30, 2023. This includes raw land for residential development and property development cost reclassified due to adoption of PFRS 15 and PIC Q&As 2018-11, 2018-15 and 2018-12. Investment properties – net increased by 2.76% amounting to Php 131.64 billion in June 30, 2023 from Php 128.10 billion in December 31, 2022. This includes raw land and property development cost for office and commercial development reclassified due to adoption of PIC Q&As 2018-11, 2018-15 and 2018-12.

Trade and other payables amounted to Php 25.79 billion and Php 24.16 billion as at June 30, 2023 and December 31, 2022, respectively, reflecting an increase of 6.77%. Contract liabilities decreased by 5.86%, amounting to Php 7.76 billion as at June 30, 2023 compared to Php 8.25 billion as at December 31, 2022. Total current and non-current customers' deposits as at June 30, 2023 amounted to Php 11.38 billion compared to Php 10.68 billion as at December 31, 2022 with 6.58% increase.

The interest-bearing loans and borrowings current and non-current amounted to Php 66.87 billion and Php 49.66 billion for June 30, 2023 and December 31, 2022, respectively, reflecting an increase of 34.67%. Bonds payable decreased by 31.48%, amounting to Php 31 billion as at June 30, 2023 compared to Php 45.24 billion as at December 31, 2022. Total other liabilities amounted to Php 15.02 billion from Php 15.41 billion as at June 30, 2023 and December 31, 2022, respectively, reflecting 2022, respectively, reflecting a a decrease of 2.50%.

Total Equity (including non-controlling interests) increased by 3.33% from Php 241.02 billion as at December 31, 2022 to Php 249.04 billion as June 30, 2023.

There were no known material events subsequent to the end of the period that have not been reflected in the Group's Financial Statements as at second quarter of 2023.

There were no changes in estimates of amount reported in the current financial year or changes in estimates of amounts reported in prior financial years.

There was no contingent liability reflected in the most recent annual financial statement, the same in the consolidated financial statements as at second quarter of 2023.

There are no commitments, guarantees and contingent liabilities that arise in the normal course of operations of the Group which are not reflected in the accompanying consolidated financial statements.

There were no other material issuances, repurchases or repayments of debt and equity securities.
